

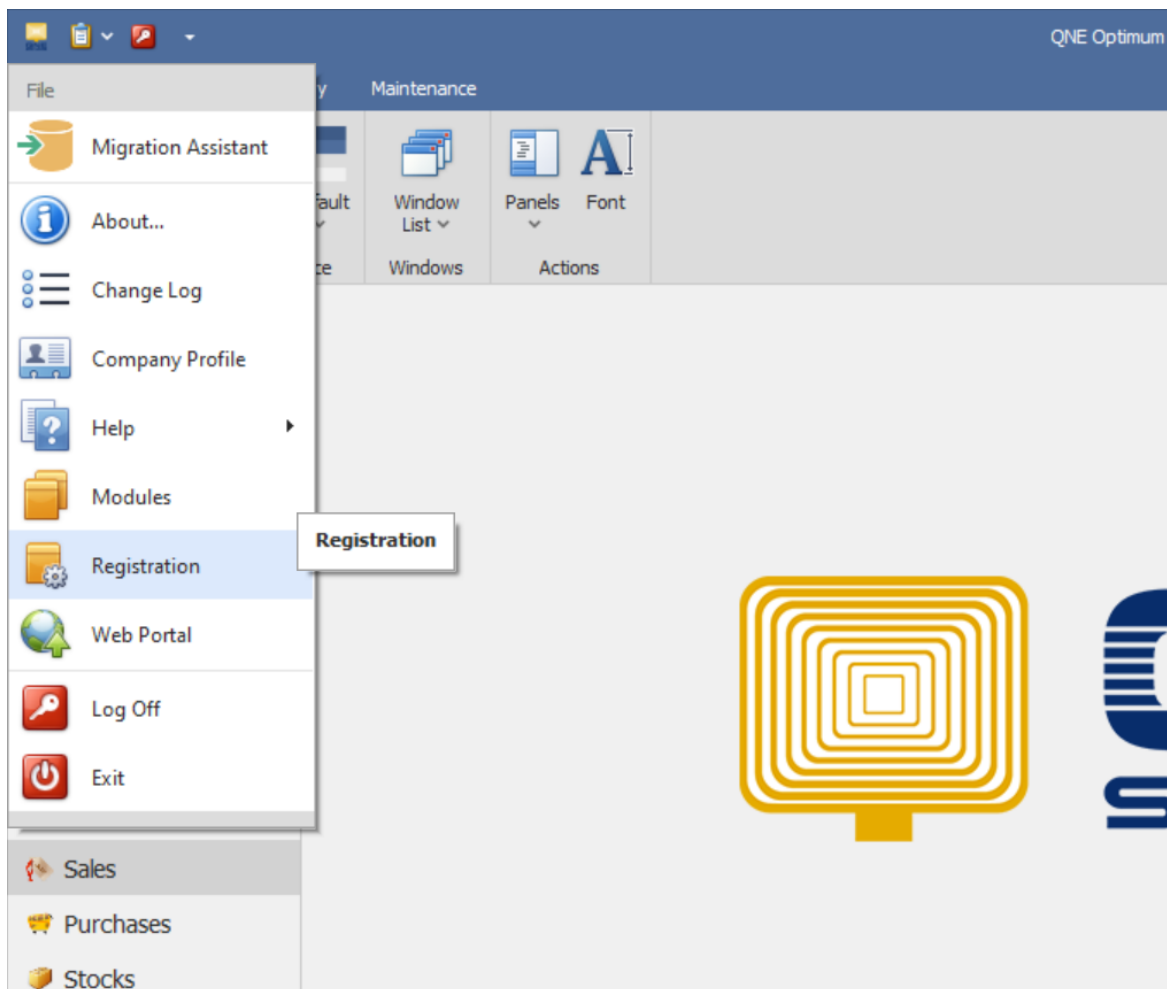


How to Perform "Update License"


"Update License" action in the system is for capturing and applying of product key's latest License Information which will be necessary once either one from below service(s) is availed:
