### Solution #1

1. If performing the first solution and you get another prompt like below, click **OK** and then close the company profile screen.





- 2. Ask all other users to log out of QNE for now. (This will only take a few minutes)
- 3. Go to *File > Registration*.
- 4. Copy or note down your license/product key. Click Transfer Out.
